TANGGAPANG PANLIGAL NG KATUTUBONG PILIPINOS

1987 ANNUAL REPORT

The PANLIPI was an off-shoot of the Paralegal Training Services Center(PTSC) which started operations in 1981. In 1982, paralegal seminars on constitutional rights were conducted by the PTSC for tribal communities. After the seminars, follow-up legal assistance was requested by these communities. Because there were specific laws particular to tribal communities, all requests were handled by Atty. Donna Zapa-Gasgonia, who made an in-depth study of these laws. As the years passed, a Task Force on Tribal Filipinos was set up by the PTSC to handle the requests of the communities. By 1986 however, only 20% of the requests of these communities were for paralegal seminars, and 80% required continuing legal assistance. The requests for legal assistance were turned down by PTSC if they were not a consequence of a paralegal seminar conducted by it. It was however clear that these services must be provided, but PTSC was limited by its organizational purpose.

Thus, in a PTSC general meeting in August 1986, it was agreed that a legal assistance center for tribal Filipinos be set up and PANLIPI started operations for the purpose of providing legal assistance to tribal Filipinos, independent of the PTSC.

The PANLIPI is a duly registered non-stock, non-profit organization(SEC No. 143908) which formally started operations on January 1, 1987. Its office address is Unit 5, Salud Apartments, 3243 Zapote St. Makati, Metro Manila, Philippines.

PURPOSES AND OBJECTIVES:

- To render advice and consultancy to Filipino non-Muslim indigenous communities;
- 2. To assist these communities in administrative, judicial and quasi-judicial proceedings;
- 3. To conduct legal research and compile legal data pertaining to the rights of these communities;
- 4. To make maximum use of legal data compiled with participatory research by systematic advocacy of policy in the government;

- 5. To coordinate with government and non-government organizations in the carrying out of this program;
- 6. To mobilize all possible resources, human and material, national and international, public and private and to accept donations and other forms of financial assistance to carry out this program and to conduct other related activities therefor.

SERVICES OFFERED:

1. LEGAL ADVICE AND CONSULTANCY

To discuss every move contemplated by the tribal communities and to advice them on appropriate actions and the legal technicalities of such actions.

2. LEGAL COUNSEL

To act as attorney for tribal communities in administrative, judicial and quasi-judicial proceedings.

3. LEGAL RESEARCH

To compile legal data and to ensure update on policies, rules and statutes.

4. POLICY ADVOCACY

To make maximum use of legal data compiled with participatory research by systematic advocacy of policies in the government thru appropriate branches, departments, bodies or agencies.

- 3. Assistance in the registration of organizations and/or cooperatives with the government.
